Council Moves to Re-Establish SEFA

On October 19, 2023, the Port Sanilac Village Council unanimously voted to rescind Resolution #03-2023 – A Resolution to dissolve the Sanilac East Fire Authority. The Village is continuing to work toward a two-entity Authority with Sanilac Township. Forester Township withdrew December 31, 2023. (Expected plan as of article submission date).
